Kuala Lumpur, 28 August 2020 - Bumi Armada Berhad ("Bumi Armada" or "BAB") today announced its second quarter ("Q2") 2020 financial results.

Revenue in Q2 2020 improved to RM606.8 million as compared to RM535.6 million in the Q2 2019 and RM552.6 million in the first quarter ("Q1") 2020. The increase in

BAB's revenue came from the FPO business, as the OMS business saw revenue decline in Q2 2020, compared to both Q2 2019 and Q1 2020.

Operating profit before impairment increased to RM246.6 million in Q2 2020, compared to RM201.3 million in Q2 2019.

BAB reported a net profit¹ of RM119.8 million in Q2 2020 versus RM78.2 million in Q2 2019.

The future firm orderbook at the end of Q2 2020 amounted to approximately RM17.2 billion, with additional optional extensions of up to RM10.1 billion.

Bumi Armada Chief Executive Officer, Gary Christenson, stated, "Bumi Armada maintained our excellent HSE performance in the second quarter with zero lost-time injuries. Our focus on FPO operations and cost reductions underpinned our financial performance.

We will continue to take a prudent approach and focus on safety, sustainability, operational excellence, and financial discipline."
